Increased adult literacy & increased access to skills training

Increased access to quality education for all children

Gender Equity & Human Rights

Increased awareness of political, social, economic rights (especially women's rights)

Increased gender equity within the family & community

Increased support & protection of indigenous cultures

Health and Nutrition

Increased access to/use of health services

Improvements in maternal and child health

Improvements in HIV/AIDS prevention and treatments

Income Generation

Women have continued access to financial services

Families are better equipped to meet household needs

Water, Environment, and Sanitation

Increased access to clean water & sanitation

Increased awareness about environmental sustainability

Improved legal protection and access to land

Local government is responsive to community needs

Increased transparency and accountability of local government
